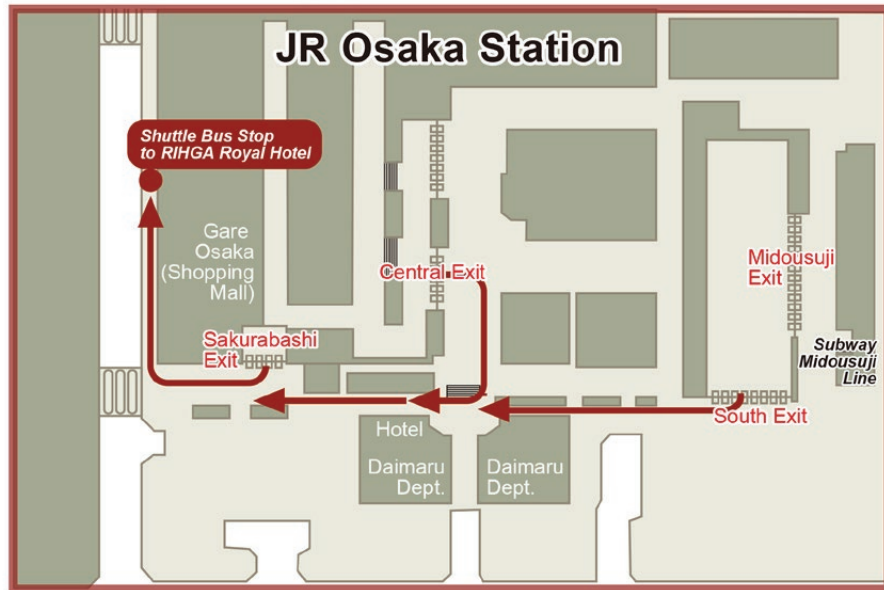


Getting to the Conference Venue

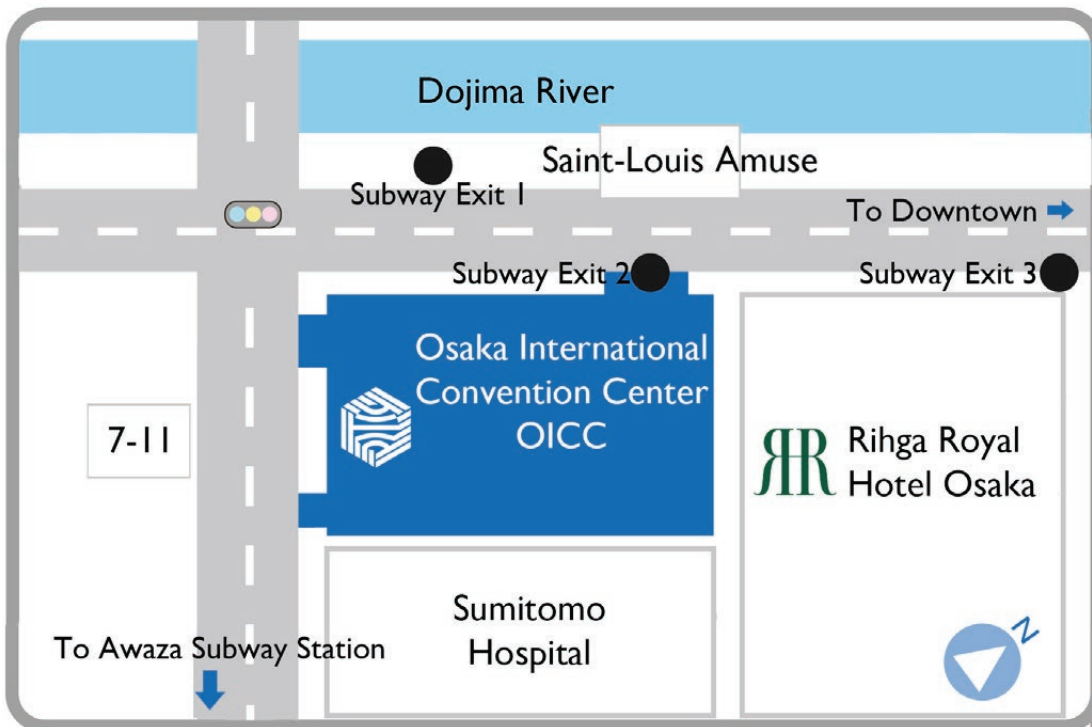

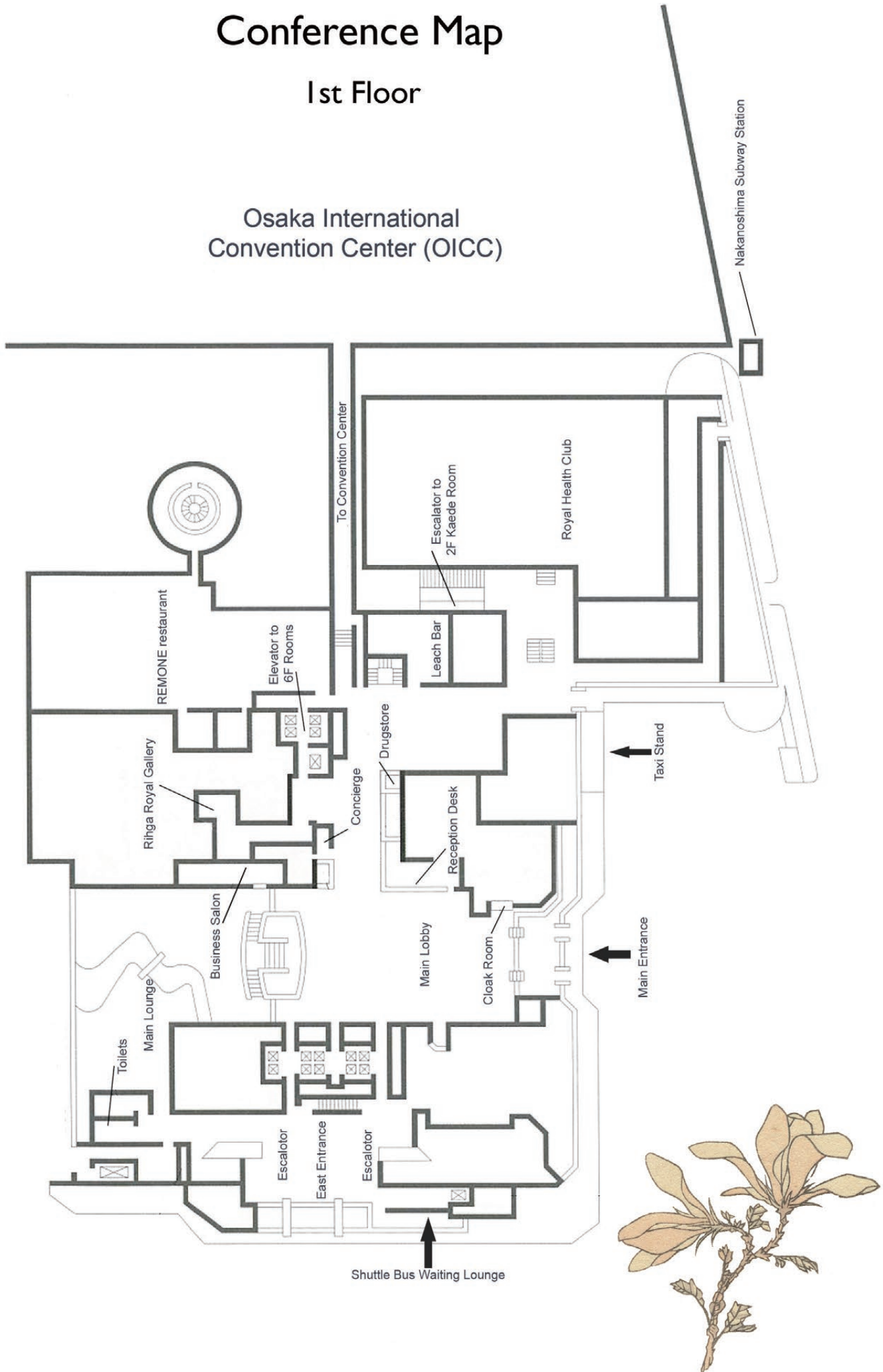

What to Wear & Bring

Attendees generally wear business casual attire. You may want to bring along a light jacket or sweater as the temperature in meeting rooms is often difficult to control.

Smoking

Conference Welcome, Keynote & Featured Session: Friday 9:00-12:15

The plenary session will be held on Friday morning, with the event beginning at 9:00 AM in the 12F Convention Hall in the Osaka International Convention Center (OICC). Please arrive in good time if you wish to attend the session. There will be an interval after the first keynote address and complimentary refreshments and snacks will be served. The plenary session will be followed by a special Taiko drum performance. Please arrive in good time if you wish to attend the session.

Parallel Speaker Sessions

Parallel Sessions will run from 13:30 on Friday afternoon, and from 9:00 AM on Saturday & Sunday morning. They are generally organized into streams. Sessions include two, three or sometimes four presenters. Each presenter has thirty minutes including Q and A time. The session length reflects the number of presenters.

Presentations and Equipment

All rooms will be equipped with a MacBook computer pre-installed with PowerPoint, as well as a screen and an LCD projector. If you wish, you may directly link your own PC laptop, although we advise you to use the computer provided by plugging in your USB flash drive.

We recommend that you bring two copies of your presentation in the case that one fails, and suggest sending yourself the presentation by email as a third and final precaution.

Session Chairs

Session Chairs are expected to introduce themselves and other speakers (briefly), and ensure that the session begins and ends on time, and that the time is divided fairly between the presentations. Each presenter should have no less than 30 minutes in which to present his or her paper, and respond to any questions.

The session chair is asked to assume this timekeeping role, and to this end, a yellow and red coloured timekeeping card is used as a visual cue for presenters, letting them know when they have 5 minutes remaining, and when they must stop.

Please follow the order in the programme, and if for any reason a presenter fails to show, please keep to the original timeslots as delegates use the programme to plan their attendance.

A Polite Request to All Participants

Participants are requested to arrive in a timely fashion for all addresses, whether to their own, or to those of other presenters. Presenters are reminded that the time slots should be divided fairly and equally between the number of presentations, and that they should not overrun.

We recommend that the 30 minutes presentation timeslot be divided as follows: 20 minutes for the paper and 10 minutes for Q and A.

Poster Sessions & Poster Requirements

The poster display boards are 1800mm high x 900mm wide. We are able to provide tape and pins. Please be aware that there are no on-site poster facilities for printing posters.

Stuart D. B. Picken

IAFOR, Japan

Stuart Picken is the Chairman of the IAFOR International Advisory Board. The author of a dozen books and over 130 articles and papers, he is considered one of the foremost scholars on Japan, China, and Globalization in East Asia. As an academic, Professor Picken has devoted more than 30 years to scholarship in Japan, notably as a Professor of Philosophy at the International Christian University in Tokyo, where he specialized in ethics and Japanese thought, and as International Adviser to the High Priest of Tsubaki Grand Shrine (Mie Prefecture).

He has also served as a consultant to various businesses, including Jun Ashida Ltd., Mitsui Mining & Smelting Corp., Kobe Steel, and Japan Air Lines. In November 2008, the Government of Japan awarded Professor Picken the Order of the Sacred Treasure for his pioneering research, and outstanding contribution to the promotion of friendship and mutual understanding between Japan and the UK. The honour is normally reserved for Japanese citizens and is a mark of the utmost respect in which Professor Picken is held by the Japanese Government.

In 2012 he was invited to London to attend a reception at the Japanese Embassy, hosted by Emperor Akihito and Empress Michiko as an expression of their gratitude towards Britons who had helped support Japan after the 2011 Tohoku earthquake and tsunami. Professor Picken helped organize fundraising efforts through both the Japan Society of Scotland, of which he is the chair, in the UK, and IAFOR in Japan.

As Chairman of the IAB, Professor Picken is responsible for the academic affairs and direction of the organization. He is also responsible for the development of the IAFOR Research Institute. Although now resident in Scotland, Professor Picken maintains his interests in Japan, as Chair of the Japan Society of Scotland, and through the IAFOR IAB. He is also the Chairman of the Academic Board of New College, Birmingham. He lives near Glasgow with his wife and two children.

Minoru Karasawa received his Master's degree from Kyoto University and Ph.D. from the University of California, Los Angeles, both majoring in psychology. After teaching at Aichi Gakuin University and Kobe University, he has been at Nagoya University since 2006. Dr. Karasawa's primary research area has been social cognition, covering various issues such as social categorization, intergroup cognition and emotions, and the role of culture and language in social inferences. He is also heading a research project on the psychological mechanism underlying judgments of responsibility and punitive motives in legal contexts. He has been an Associate Editor of the Asian Journal of Social Psychology and the Editor of the Japanese Journal of Social Psychology. Academic associations that he has served as a board member include the Japanese Society of Social Psychology, the Japanese Group Dynamics Association, and the Japanese Society for Law and Psychology. He has been a member of the Science Council of Japan since 2006.

Keynote Speech: Blameworthy Character Invites Harsher Punishment: A Social Psychological Approach to Punitive Motives against Individuals and Groups

Ordinary people typically think that it is fair to punish an individual, and a group, who has certain undesirable characters such as immoral proclivity. In this presentation, I will discuss why and how this intuitive judgment of fairness against unwanted character is formed. First, I will point out that there are at least two different kinds of views that may govern punitive motives; that is, utilitarian judgments and the sense of retributive justice. I will then present findings from social psychological studies that demonstrate different roles of these two views that lead to harsher punishment of immoral or inhuman criminal defendants. Next, I will turn to pointing out the lay tendency to regard social groups and organizations (e.g., corporates) as entitative social agents, just like individual actors. This may lead to blaming the group as an independent and responsible entity in case of its wrongdoing, and thereby resulting in actual punitive behavior such as boycotting. Theoretical models as well as empirical evidence will be presented to elucidate psychological processes underlying the animating perception of group agents. Possibilities of interplay between psychological studies of person/group perception and those of morality judgments will be discussed.

Frank S. Ravitch is Professor of Law and the Walter H. Stowers Chair in Law and Religion at the Michigan State University College of Law, and Director of the Kyoto, Japan Summer Program. He is the author of several books: *Marketing Intelligent Design: Law And The Creationist Agenda* (Cambridge Univ. Press, 2011); *Masters Of Illusion: The Supreme Court And The Religion Clauses* (NYU Press 2007); *Law And Religion, A Reader: Cases, Concepts, And Theory*, 2nd Ed. (West 2008) (First Ed. 2004); *Employment Discrimination Law* (Prentice Hall 2005) (with Pamela Summers and Janis McDonald); and *School Prayer And Discrimination: The Civil Rights Of Religious Minorities And Dissenters* (Northeastern University Press, 1999 & paperback edition 2001). Professor Ravitch has also published a number of law review articles addressing U.S. and Japanese constitutional law, law & religion, and civil rights law in leading journals. Moreover, he has written a number of amicus briefs addressing constitutional issues to the United States Supreme Court.

In 2001, Professor Ravitch was named a Fulbright Scholar and served on the Faculty of Law at Doshisha University in Kyoto, Japan. Currently, he directs the Michigan State University College of Law Japan Summer program. Professor Ravitch regularly serves as an expert for print and broadcast media, and speaks on topics related to U.S. Constitutional Law, Japanese Law, and Israeli Law to a wide range of national, international and local organizations. He speaks English, Japanese, and Hebrew.

Keynote Speech: Government Officials' Visits to the Yasukuni Shrine: Constitutional and Ethical Struggles

For those familiar with Japan, the simple mention of the Yasukuni Shrine raises the specter of controversy. The Shrine is an edifice of the Meiji Era that sprung from humble beginnings into the site of international controversy. The shrine was originally created in 1879 to commemorate government soldiers killed in the Boshin War; but it has grown into a symbol of Japanese nationalism, militarism, and historical revisionism, which is controversial to many people within the pacifist culture in Japan, and to people in China, Korea and Taiwan.

Among those enshrined there today are those involved in military expansionism and war crimes. This includes fourteen Class-A war criminals who were secretly enshrined without public knowledge. There are, of course, many enshrined there who did not commit war crimes, but the cultural meaning of the shrine is itself controversial within Japan, which has become a culture deeply rooted in pacifism. Moreover, to many Koreans, Chinese, Taiwanese and others, visits to the shrine by high-ranking government officials is an offense. Visits to the shrine by government officials create an ethical and cultural struggle for many Japanese, who are surprised to learn of international reaction to the visits, and yet feel deeply committed to avoiding conflict.

Japan is a constitutional democracy, however, and whether or not visits to the Yasukuni Shrine by the government officials are offensive and ill advised, the question remains whether those visits are constitutional. Most courts to consider the question have held the visits are constitutional, but at least one court, the Osaka High Court, held the visits are unconstitutional. This talk explains why the Osaka High Court correctly interpreted the Japanese Constitution. Moreover, the talk addresses why this approach is consistent with the ethical commitments of many in Japan, who accept pacifism as part of the cultural dasein.

Lowell Sheppard is Asia Pacific Director of the HOPE International Development Agency, an organization focused on working with the world's extreme poor in their quest to climb out of poverty. Aside from his 25-year involvement with Hope, Lowell has dedicated much of his life to social and environmental improvement projects throughout the world. He was the chairman of the Whose Earth initiative in the United Kingdom, and was the founding chairman of Novimost, a non-government organization responding to the needs caused by war in the Balkans. He was also CEO of one of the United Kingdom's largest youth charities and an executive member of Spring Harvest, an annual Christian festival which attracts more than 60,000 people each Easter; and raises more than one million dollars for charities every year. A fellow of the Royal Geographic Society, Mr Sheppard is the author of six books, which reflect his diverse intellectual interests, and life experience. His latest book, *Boys Becoming Men*, examines the importance of rites of passage, including adventures, for children becoming adults. Lowell is a noted public speaker, and has given lectures at both undergraduate and postgraduate level on Corporate Social Responsibility and Sustainability, and he is a former vice-chairman of the CSR Committee for the American Chamber of Commerce in Japan.

Featured Speech: Individual, Community and Society: Conflict, Resolution and Synergy

Drawing on his experience working in and writing about, intensely dysfunctional communities the result of war, disaster and extreme poverty, Lowell Sheppard will present a personal perspective on the makeup of conflict and how it can spark transformation in communities experiencing conflict politically, environmentally, socially and generationally. Lowell will also explain the mission of Hope International as an international development agency which exists to improve the supply of basic human necessities for the neediest of the needy in the developing world through self-help activities, and to challenge, educate and involve Japanese residents regarding development issues and global education.

Jiro Takai is professor of social psychology at Nagoya University, and received his PhD from the University of California, Santa Barbara. He has served in the executive committees of the Japan Society for Social Psychology, the Japan Group Dynamics Society, the Japan Intercultural Education Society, the Communication Association of Japan, and the Japan-US Communication Association (affiliate of National Communication Association). Although he was born in Japan, he spent 15 years as a youth growing up in Canada, and has also spent two years living in the United States. Because of such a background, he has an interest in cross-cultural matters, particularly in the context of interpersonal communication as well as research interests in interpersonal competence, self-presentation and Multi-faceted self concept.

Featured Speech: Rethinking interpersonal conflict strategies: Is *avoiding* really that bad?

Conflict abounds in our everyday relationships, and their skillful management is the key to interpersonal harmony. In dealing with conflict, the received view is that we should directly confront the other party with the issues, followed by constructive, mutual communication, negotiating a solution which leads to both parties being able to fully fulfil our respective goals. Rahim (2002) calls this the integrating conflict style. At the other end of effectiveness scale is the avoiding conflict style. Avoiding leaves the issue outstanding, with the other party not aware of doing you any injustice, and your dissatisfaction with him/her increasing until you snap. Avoiding, according to Rahim (2002), lacks self-concern, as well as other-concern, leaving nothing resolved, and surely ending up in a lose-lose situation. But is avoiding really such a bad strategy? My graduate students and I have been studying conflict styles of Japanese, and our opinion is that avoiding is quite effective. This talk will elaborate on why, when and how avoiding can actually be a wise choice in managing interpersonal conflict.

Monty Satiadarma is an academic and psychologist who has lectured around the world, and who continues to practice in his native Indonesia. He was the Dean of the department of psychology at Tarumanagara University from 1997-2005, and Rector of the University from 2008-2010. Dr Satiadarma has a particular interest in educational psychology, and in music and art therapy, methods with which he treated survivors of the Indonesian tsunami on behalf of the International Red Cross and the United Nations. He is a board member and area chair of the International Council of Psychology, and a founder and board member of the Asian Psychology Association.

Featured Speech: Being Responsible: A Personal Challenge in Resolving Conflicts

Conflict is an integral part in human life. Kurt Lewin in his field theory described various conflict conditions within a person in a process of decision making. Lawrence Kohlberg in his moral theory explained how a person deals with conflicting situations prior to execute an action. Numbers of social theorists reported how people must deal with their social roles, and the Freudian concept has discussed extensively various forms of conflicts between the id and superego, between drives and ethical concerns. Remaining in a conflicting situation creates tension. Tension may increase preparedness and readiness in numbers of life challenges, but tension that remains in a lengthy condition can become preconditions for pathology. While defense mechanisms may resolve challenging problems temporarily, they are extending the possibility of inner conflicts. Honesty, acceptance and genuineness are important aspects for people to resolve conflicts. Fear on the other hand inhibits conflict resolution, and preventing potential synergy in human interactions. Fear to choose allowing someone to remain in conflicting situation thus maintaining tension. Fear to accept creates denial to self which gradually take a person into alienation. Conflict resolution needs courageous responsible act. Being responsible is a great challenge for many people, yet it is a strong remedy to resolve conflicts.

For **Dr. Kurt R. Bickford** the pursuit of higher education is really the pursuit of knowledge leading to competence in training others to maximize their own personal growth and development. While education at the earlier levels (high school through bachelor's level) was often boring and uninteresting, advanced training became increasingly intriguing and rewarding. Dr. Bickford has earned two Master's degrees and a Doctorate in Clinical Psychology, with specialization training in a number of areas including neuropsychology, neurotherapy, hypnosis, family systems and couples work. In addition to professional standing as a licensed Clinical Psychologist, he is also a licensed Marriage, Family and Child Therapist, a credentialed Educational Psychologist, and credentialed teacher. He is also an Independent Medical Examiner for the State of California.

Dr. Bickford has practiced in the profession of psychology at a variety of levels since 1974, including positions at California State Hospital (Pacific State), Veterans Administration Hospital (J. Pettis VA Hospital), San Bernardino County Department of Behavioral Health, community clinics, teaching, counseling and educational psychologist positions in four California school districts, and a private practice in Redlands, California for the past twenty-five years. This practice has evolved to include executive and Consciousness coaching, working with private industry, educational institutions and healthcare systems. Dr. Bickford has also served as an expert witness for the Superior Court system in California. He continues to pursue advanced training from masters in the field, and is now teaching and training others in the understanding of human behavior; and the path of higher consciousness through a seminar series and a monthly radio show. He believes that all things start with the self/Self.

Dr. Tracy J. Covington traveled an eclectic path, pursuing many interests before finding her passion in the field of psychology. Upon completion of a Master's Degree followed by a Doctorate in Clinical Psychology, she began her career as an Assistant Professor and Staff Psychologist at Loma Linda University Medical Center (LLUMC), Department of Anesthesia, in Southern California. During her tenure at LLUMC, she enjoyed opportunities integrating psychological concepts with a diversity of chronic pain conditions and life threatening illnesses. This included the creation of Transitions, a clinical support group specific to young adults challenged by severe health conditions such as cancer. With her life and business partner, Dr. Kurt Bickford, she developed a rehabilitation center for the treatment of chronic pain and stress conditions where she developed and utilized an inter-disciplinary approach, now a standard in the industry. Opportunities to share this treatment model and research were offered at both national and international levels. Her private practice of 23 years has been a composite of services including psychotherapy, applied physiology, executive and organizational coaching, collaboration on professional monthly seminars, a monthly radio show and a variety of publications emphasizing consciousness, psychology, temperament and the possibilities of the human endeavor. Dr. Covington is a licensed Clinical Psychologist who is Board Certified in Biofeedback and a Diplomate in Pain Management.

Dexter Da Silva is currently Professor of Educational Psychology at Keisen University in Tokyo. He has taught EFL at junior high school, language schools, and universities in Sydney, and for the past two decades has been living and teaching at the tertiary level in Japan. Professor Da Silva was educated at the University of Sydney (BA, Dip. Ed., M.A.), and the University of Western Sydney (Ph.D.) He has presented and co-presented at conferences in Asia, Australia, Europe and the U.S., and written or co-written articles and book chapters on education-related topics, such as trust, student motivation, autonomy, and content-based language teaching. He is a past editor and current associate editor of *On CUE Journal*, regular reviewer for conferences and proceedings, and recent co-chair of the 2011 CUE Conference on Motivation.

“To Open Minds, To Educate Intelligence, To Inform Decisions”

The vision of IAFOR grew out of the perceived need to fill a vacuum in the communication and exchange activities of the academic world. Its mission arose out of examining that space and investigating why it existed. The vacuum existed because of the lack of opportunity for serious and thoughtful exchange between academics, members of the global business community, and practitioners in the fields of human endeavor that linked these groups together. In the field of education, for example, we have academic theorists, educational managers (political decision-makers and organizational directors) and classroom teachers with their support staff in IT, library work, exchange programs, and specialist fields. But how often do they have the opportunity to interact?

Moving beyond one particular field, larger questions arise. What function should universities prioritize in the 21st century? What do businesses see as their contribution to social and global well being? How can people on the ground, trying to implement improvements that will transform human life, best be supported? And perhaps above all, what are the agendas that will drive mechanisms to enable these groups to interact effectively.

One piece of distilled thought that came from early exchanges at one of our conferences was the recognition that some of the rhetoric of concern about the problems of developing nations was perhaps over-focused on the term “poverty” because it can be defined only in a relative way. “Hunger” was put forward as being more immediate and itself a contributory factor to poverty, rather than the other way round. One key to the hunger issue could be the provision of safe drinking water; or water for irrigation in some contexts, while flood management might be necessary elsewhere. These, in and by themselves become valuable only insofar as they help to relieve hunger in specific contexts.

IAFOR is affording opportunities that do not exist elsewhere. The base is Osaka, Japan’s great commercial and manufacturing hub, one symbol of the emerging Pacific economy that is already eclipsing the long dominant Atlantic zone. Our conferences present those taking part with three unique dimensions of experience. First of all, it encourages interdisciplinary activity to be expanded. Depending on the field, this can face varying degrees of difficulty, ranging from discouragement to downright prohibition. Those overly dependent on fixed academic structures often see lateral thinking as a threat. None of these negatives apply in IAFOR. Its purpose is to generate new approaches that cross any disciplinary lines. The principle employed is to let the imagination permit intuitive responses to questions. There are no panels of critics. There are simply people who want to listen and reflect. The model of academic work as potholing is replaced by the metaphor of mountaineering. While respecting the need for solid and well-founded academic work, we feel the need to go beyond it from time to time to discover fresh approaches to old questions.

Secondly, it facilitates the heightening of intercultural awareness. Again, we encourage innovation through cross-cultural perception. Cultural roots influence people in their attitudes more than most would realize or admit. The need to see and internalize insights gained from other viewpoints is met by a process of steady illumination.

Thirdly, it promotes the broadening of international exchange. We may live in a globalized world, but in reality parochialism still holds sway. The collapse of the U.S.S.R and the break-up of Yugoslavia led to the re-establishment of numerous former countries. While this may be desirable for the peoples concerned, it merely adds to the world’s cultural confusion. Exchange leads to explanation and that helps the growth of intercultural awareness.

IAFOR makes all of these developments possible in one gathering. Our conferences are not a substitute for specialist conferences. We intend our events to be an alternative that functions as a balance or even a corrective to the extreme tendencies that can arise from more narrowly defined research parameters. In short, IAFOR is promoting and facilitating a new multifaceted approach to one of the core issues of our time, namely globalization and its many forms of growth and expansion. Awareness of how it cuts across the worlds of business, and academia, along with its impact on societies and institutions is one of the driving forces that has given the organization its momentum, and is making it a pioneer in this global age.

The Reverend Professor Stuart D. B. Picken, Order of the Sacred Treasure, M.A. (Hons), B.D., Ph.D. (Glasgow), F.R.A.S.

Professor Picken is the Chairman of the IAFOR International Advisory Board. The author of a dozen books and over 130 articles and papers, he is considered one of the foremost scholars on Japan, China, and Globalization in East Asia. As an academic, Professor Picken has devoted more than 30 years to scholarship in Japan, notably as a Professor of Philosophy at the International Christian University in Tokyo, where he specialized in ethics and Japanese thought, and as International Adviser to the High Priest of Tsubaki Grand Shrine (Mie prefecture). He has also served as a consultant to various businesses, including Jun Ashida Ltd., Mitsui Mining & Smelting Corp., Kobe Steel, and Japan Air Lines. In November 2008, the Government of Japan awarded Professor Picken the Order of the Sacred Treasure for his pioneering research, and outstanding contribution to the promotion of friendship and mutual understanding between Japan and the UK. The honour is normally reserved for Japanese citizens and is a mark of the utmost respect in which Professor Picken is held by the Japanese Government. More recently, in 2012 he was invited to London to attend a reception at the Japanese Embassy, hosted by Emperor Akihito and Empress Michiko as an expression of their gratitude towards Britons who had helped support Japan after the 2011 Tohoku earthquake and tsunami. Professor Picken helped organize fundraising efforts through both the Japan Society of Scotland, of which he is the chair, in the UK, and IAFOR in Japan. As Chairman of the IAB, Professor Picken is responsible for the academic affairs and direction of the organization. He is also responsible for the development of the IAFOR Research Institute. Although now resident in Scotland, Professor Picken maintains his interests in Japan, as Chair of the Japan Society of Scotland, and through the IAFOR IAB. He is also the Chairman of the Academic Board of New College, Birmingham. He lives near Glasgow with his wife and two children.

Professor Jerry Platt, B.S. (Michigan State), MBA (Wayne State), MA, PhD (Ohio State), MS (Stanford)

Jerry Platt is Professor of Global Business at Akita International University, Japan and Professor Emeritus at San Francisco State University. Professor Platt holds a B.S. in Multidisciplinary Social Sciences from Michigan State University, an MBA from Wayne State University, an M.A. in Public Administration, and a Ph.D. in Public Policy and Management from the John Glenn School of Public Affairs at Ohio State University, and an M.S. Statistics Post-Doctoral Degree from Stanford University. His research interests span business, technology and public policy and he is the author of over 85 peer-reviewed papers in these and associated fields. Balancing industry with academic interests, Jerry also served as head of financial analysis for a Bay Area Fortune 500 company, and as CEO of an aviation firm. He has been Principal Investigator on more than twenty U.S. federal research grants. From 1976-2004, Professor Platt was on the faculty of the School of Business at San Francisco State University, and was named Dean in 2001. From 2004 he was Senecal Endowed Dean of the Business School at the University of Redlands, California, before holding concurrent professorships at Redlands and Akita International University, Japan from 2010 until 2012. As Vice-Chair of the IAFOR International Advisory Board, Professor Platt advises the organization on matters pertaining to IAFOR's development and strategy, as it faces the challenge of sustainable growth as both a regional and global organization.

Joseph Haldane is the Executive Director of the International Academic Forum. He was Academic Director from IAFOR's inception in 2009 until January 2011, when he assumed his current enlarged role. He is responsible for setting policies, forging institutional partnerships, implementing projects, and overseeing the research and publications of the organization, as well as maintaining responsibility for overseeing IAFOR's growing global operations. Joe's academic interests include politics and international affairs, literature, history, and the history of ideas, and he holds a PhD from the University of London in French Studies. 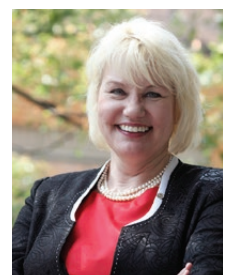
Steve Cornwell is Professor of English and Interdisciplinary Studies at Osaka Jogakuin University, and also teaches in the online portion of the MATESOL program for the New School in New York. He helped write and design several of the New School courses and has been involved with the program since its inception. He is involved with the Japan Association for Language Teaching (JALT) serving on its National Board of Directors. Since 2012 he has been the Committee Chair of Osaka Jogakuin University's Lifelong Learning Committee and is responsible for their evening extension program geared at alumni and community members. He is also the Vice-Chair of Osaka Jogakuin University's English Education Committee and recently served as the country coordinator for Teachers Helping Teachers' Bangladesh Team. An American who has made Osaka his home, Professor Cornwell first became involved with IAFOR as a featured speaker at the first ACE conference in 2009, and has gradually become more involved in the organization, and in his capacity of Local Conference Chair, now assists in the logistical and administrative side of every event. He advises extensively on academic matters too, with particular responsibility for overseeing and developing the programs of the ACLL/ACTC conference in Japan, and the ECE/ECLL/ECTC event in the UK.

Professor Marjo Mitsutomi, B.A. (Anderson University), M.A., Ph.D. (Ball State University)

Marjo Mitsutomi is multilingual, and Professor and Executive Director of the Language Education Institute (LEI) at Osaka Gakuin University, Japan. Prior to her current position at OGU, she was academic director of three language acquisition programs at Akita International University, Japan. For many years, Dr. Mitsutomi was on faculty at the University of Redlands in Southern California, where she taught in the School of Education's graduate program, represented the entire university faculty as their elected president for academic governance, and served as director on the Orange County campus. A native of Finland, Dr. Mitsutomi holds a Ph.D. in Applied Linguistics, is fluent in three languages and conversational in another three. Dr. Mitsutomi has participated in several cross-disciplinary projects involving language development, planning and policy. She has consulted with the California Commission on Teacher Education and the United States Federal Aviation Agency (FAA). Her most notable contribution as a linguist was as co-author of the International Civil Aviation Organization (ICAO) aviation English proficiency standards for pilots and air traffic controllers worldwide. This ICAO proficiency standard (adopted by vote at the United Nations) governing both native and non-native speakers of English is the first global language mandate of its kind.

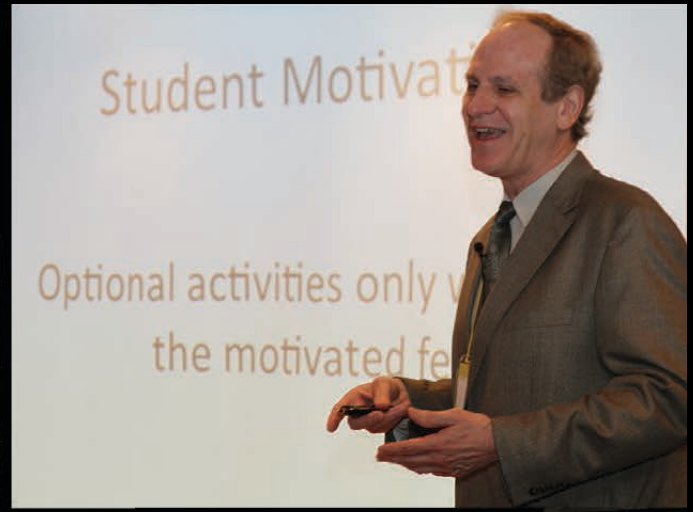

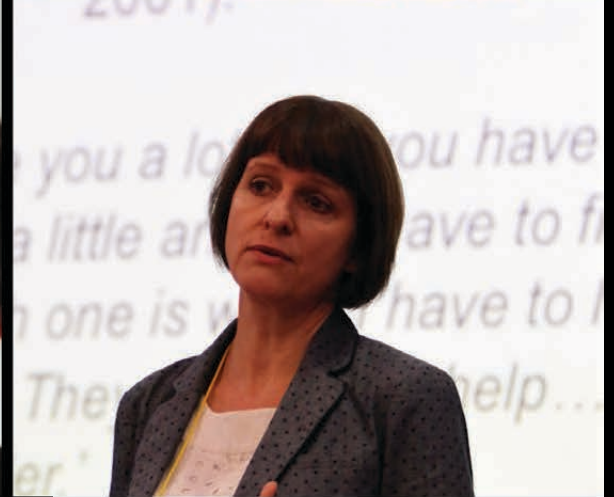

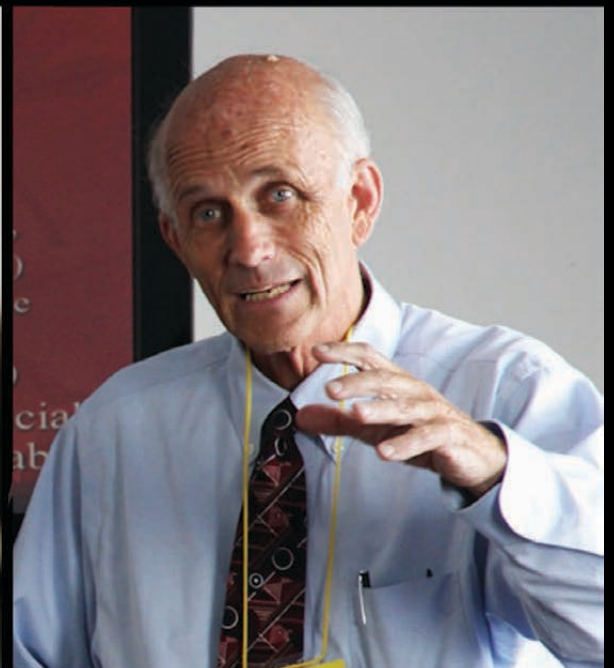

How are journal editors appointed?

Journal Editors are appointed by the International Academic Forum's leadership, under the guidance of the Chairman of the International Advisory Board. The term of appointment is for one issue, to be renewed by mutual consent.

How do we ensure academic integrity?

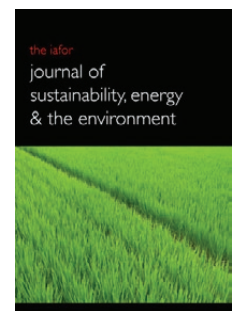
Once appointed, the editor is free to appoint his or her own editorial team and advisory members. All papers published in the journal have been subjected to the rigorous and accepted processes of academic peer review. Neither editors nor members of the editorial team are remunerated for their work. Authors will never be asked to "contribute" towards publication costs.

How are papers selected?

Journal Editors may accept papers through an open call, and proposed articles may be sent directly to the respective editors. A small number of papers from the associated IAFOR conference proceedings may also be selected by the journal editor(s) for reworking and revising subject to normal processes of review. It is expected that between 5 and 10 percent of papers included in any given conference proceedings will be developed for inclusion in the associated conference journal.

How are IAFOR Journals related to IAFOR conferences?

IAFOR's journals reflect the interdisciplinary and international nature of our conferences and are organized thematically. Papers included in the associated conference proceedings may be considered for reworking by the editor(s), and would then be subjected to the same processes of peer review as papers submitted by other means.



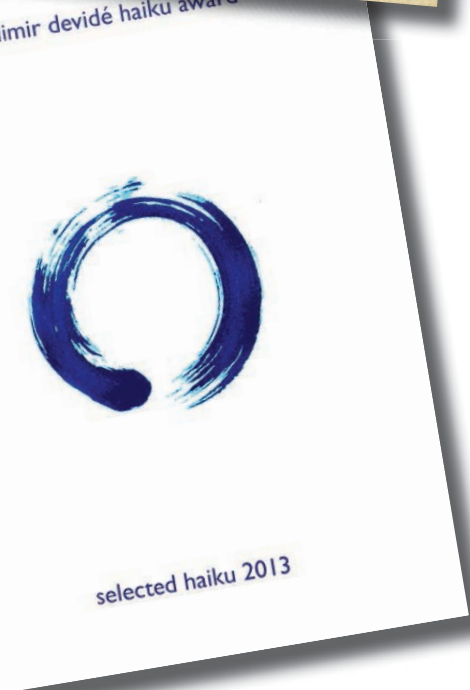

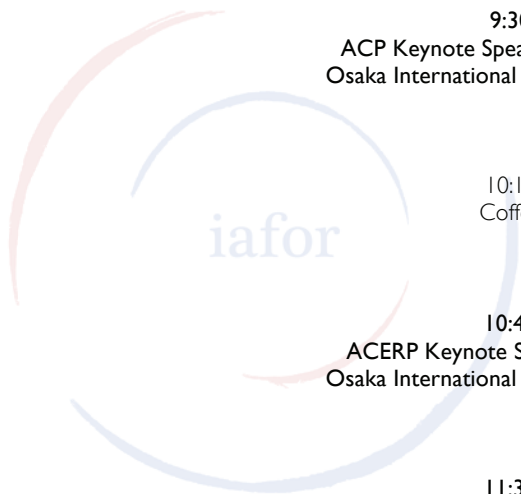
